SUBMISSION INFORMATION FOR INTERNATIONAL CONFERENCE IN 2022

1. Article content

- 1.1. Articles submitted to scientific seminars are legal scientific research articles with new contents, announcing research results, introducing domestic and international experiences, scientific exchanges, commentaries and criticisms on theoretical and practical issues that are the subject of the conference.
- 1.2. Conference submissions must not be published in newspapers, proceedings and other journals. The author is the owner of the article and is responsible for all scientific content, as well as information, materials, data, illustrations,... in the article.

2. Language:

Submissions must be in English.

- **3. Structure:** The article is presented in the following order:
 - Name of the article;
 - The author, affiliation:
- Summary/Abstract (English, not exceeding 200 words, and must reflect the most important results of the research);
 - Keywords;
 - Content of the article;
 - Acknowledgment (if any);
 - References;

Please provide details of majors, degrees, academic titles, work addresses, e-mail, phone numbers of the Correspondent Authors (at the bottom of the first page)

4. Format

- Font: Time New Roman. Size 12;
- Line spacing: Single;
- Top & bottom margin: 2.0 cm, left margin 3.0 cm, right margin 2.0 cm;
- The distance between two paragraphs: 3pt;
- Each article must not exceed 10 A4 pages.

5. Pictures, tables

Requires the author to send the original image with the article; Formula: mark with Mathtype software.

- **6. References** are numbered in square brackets according to the order of appearance in articles and recorded in the list of references in the following manner:
- For journal articles: name of author, year of publication, title of the article (in italics), journal title, volume, first page of the article. For example:
- [1]. Le Thi Hoai Thu (2018). *Unemployment Insurance under the Law on Social Insurance in Vietnam something to discuss*. Journal of State and Law 11, 59.
- For books: author's name, year of publication, title (in italics), publisher, place of publication. For example:
- [2]. Ngo Huy Cuong (2006). *Democracy and Democratic Law*. Justice Publishing House, Hanoi.

Articles will be reviewed and edited for publish at the Conference Proceedings with ISBN numbers.
