



MEMORANDUM OF UNDERSTANDING between University of Central Lancashire and

Hanoi University of Natural Resources and Environment

University of Central Lancashire (UCLan) Lancashire, England and Hanoi University of Natural Resources and Environment (HUNRE), Hanoi, Vietnam

With the objective of consolidating and promoting the cooperation in the field of education and training, UClan and HUNRE (hereinafter referred to as "both Parties") have reached the following understanding:

- 1. Mutual benefit can be derived from scholarly interaction, cultural interchange, cooperative research the sector of natural resources and environment and other forms of academic collaboration in accordance with the two sides within this Memorandum.
- 2. The contents of cooperation are detailed below:
- (i) Exchange of academic staff members, students and PhD. Candidates;
- (ii) Collaborative research and possible exchange of academic papers;
- (iii) Mutual assistance in the preparation of seminars, conferences and workshops;
- (iv) Exchange of academic publication materials or other information;
- (v) Cooperation in training projects and possible joint delivery of short-term training for specified areas of development for officials, lecturers and students of the natural resources and environmental sectors;
- (vi) The potential development of articulation programs at an undergraduate level and postgraduate level;
- (vii) Opportunities for other forms of cooperation, such as the delivery of award and non-award courses, and other areas as agreed.

- 3. The terms of specific areas of cooperation shall be further considered and agreed upon in writing by the parties prior to the initiation of any particular activity.
- 4. Any specific program will be subject to availability of funds and approval by both parties.
- 5. The parties agree that this Memorandum of Understanding is not a formal legal agreement giving rise to any legal relationship, rights, duties or consequences, but it is only a definite expression and record of the purpose of the parties to which the parties are bound in honor only.
- 6. This Memorandum of Understanding shall remain in effect for a period of five (05) years from the latest date of signature. And it is made in 02 copies in English, each Party keeps one copy, has the same validity. This Memorandum may be amended or modified at any time by the mutual consent of the related parties.
- 7. The Memorandum can be terminated at any time by either party upon provision of six (6) months' written notice to the other party. The activities under this cooperation still continue until the end without being affected by the end of this memorandum.
